



### Payment Contract

- \$59.00 monthly\*
- \$636 annually\*\* – Credit card will be charged \$53.00 per month
- \$75.00 punch card for 10 coached workouts (valid for 3 calendar months from the date of purchase)
- \$40.00 quarterly business sponsorship package – business logo placement on team website for 3 calendar months
- \$100.00 annual business sponsorship package – business logo placement on team website for 12 calendar months

\*Monthly membership dues will be charged on members' credit card the 1<sup>st</sup> of every month. Monthly membership rates may be subject to change at anytime. All members will be given a 30 day prior notice of rate increase. If a member wishes to cancel their membership, a 30 day written notice is required on or before the 1<sup>st</sup> of the prior month the member wishes to cancel. \*\*Annual membership dues will be divided into 12 month installment payments of \$53.00 and charged to members' credit card the 1<sup>st</sup> of every month. All members in an annual agreement will not be subject to rate increases during the duration of the annual agreement. If a member wishes to cancel their membership, a 30 day written notice is required on or before the 1<sup>st</sup> of the prior month the member wishes to cancel. Members on an annual agreement that terminate the contract prior to completion of the twelve month period will be charged two months of the current membership fee for early cancellation.

Members may take one calendar month leave of absence (LOA) per year without paying membership dues. A 30 day written notice is required on or before the 1<sup>st</sup> of the month prior to taking the one month LOA. If the member wished to extend the LOA for more than one calendar month, the member will be charged \$20.00 per month. After an additional 3 month LOA the membership will be canceled and all early cancellation fees will apply. If the member re-joins the team they will be considered a new member and subject to the annual membership fee. Medical LOA due to injury, pregnancy or illness requires a physician's written notice to place the membership on hold status. Any membership dues paid prior to the medical LOA will be used as credit when member returns and membership will be reactivated

All new and active members will be charged an annual membership fee of \$20.00 to be used for the purchase or replacement of equipment, team awards, meet relays, and coach's enrichment courses. New members will be charged at the time of sign up. All active members will be charged the annual membership fee on the 1<sup>st</sup> of January each following year. Any merchant fees or bank charges due to member's insufficient funds will be at the expense of the member.
